



Survey of "Addition to Peter's Lott" for Peter Gordy II

Peter Gordy I received a common warrant for "Addition to Peter's Lott" containing 50 acres in Worcester County Maryland on 14 December 1755. On 21 March 1759 a survey of the land was recorded and he assigned the warrant to his son, Peter Gordy II. The document includes the survey description and plat. We do not have the citation information.

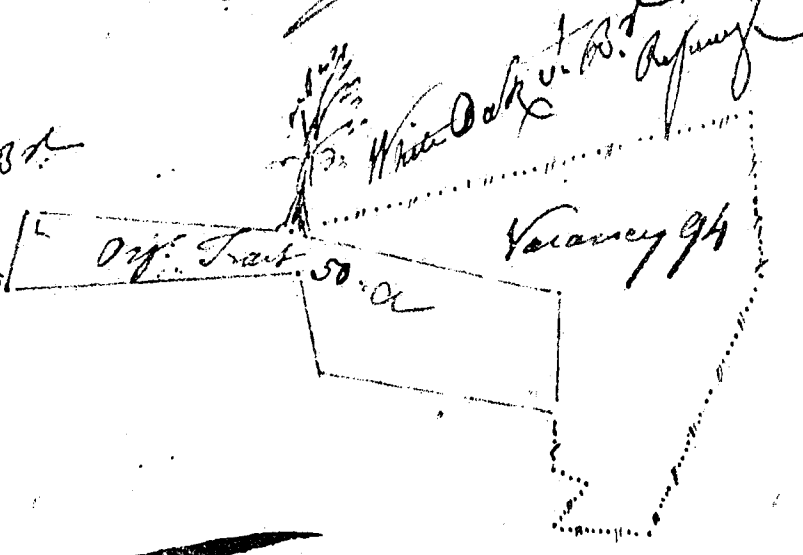

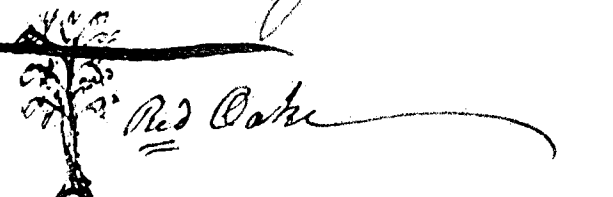
