



Addition to "Peter's Lott" Renamed "Peter's Choice"

Additional adjacent land was added to the 50 acres of "Peter's Lott" and the new combination was renamed "Peter' Choice" and contained 190 acres total. This document is the survey filed on 26 August 1762 for Peter Gordy II of the land now called "Peter's Choice" and located in Worcester County Maryland.. The document includes a survey description and plat. The only citation information available is folio number 327.

Maryland Worcester County

August 26. 1762

By Virtue of a special Grant granted unto Peter Gordy Esq. of the County bearing date the 10th day of March Anno Domini 1752 To have a Tract or parcel of Land called Peter's Land Originally on the day of anno Domini granted unto the said Peter Gordy Esq. for 50. Acs of Land under New Grant

That I James Howard Deputy Surveyor of the County under the Hon. Benj. Jeare Esq. Surveyor Genl. of the Eastern Shore have accordingly before me laid out for the said Peter Gordy Esq. of the County 50. Acs of Land agreeable to its ancient Meas. & boundaries as follows to which I have added One Hundred & forty Acres of vacant Land which makes in the whole One Hundred & Ninety Acres of Land lying & being in the County of back in the County of Dorset bounded as follows Beginning at the Ridge of a little Hill standing on a flat Ridge called Wolf Pitt Ridge on a North side of a Ravine & being the Orig. Bounder thereof thence running N. 30. W. 22 y. thence S. 22. W. 20 y. thence S. 30. W. 32 y. thence S. 25. W. 26 y. thence S. 72. W. 40 y. thence S. 20. E. 12 y. thence S. 10. W. 16 y. thence N. 85. = 11. 20 y. thence S. 10. W. 32 y. thence N. 73. E. 86 y. thence S. 79. E. 122. y. thence N. 62. E. = 30 y. thence N. 67. E. 52 y. thence S. 63. E. 44 y. thence N. 73. E. 30 y. thence N. 70. = 30 y. thence N. 30. E. 52 y. thence N. 25. W. 70 y. thence N. 70. W. 47 y. thence thence with a Right Line to the first Bounder containing & now laid out for One Hundred & Ninety Acres of Land more or less to be held of the Manor of Worcester now called Peter's Choice
